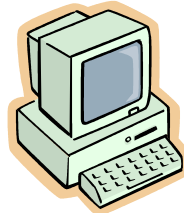

Seminar Overview:

Addictions 101: Getting Back to Basics is an education seminar that incorporates didactic presentation and stimulating audience interaction. It has been designed as an introductory course for entry level addictions professionals as well as for public health personnel seeking to expand their knowledge of addictions.

Learning Objectives:

1. Participants will learn the textbook definition of substance abuse, alcoholism and related terms according to important references such as the DSM-IV-TR.
2. Participants will learn and discuss the negative consequences of substance abuse and review current statistics on this issue.
3. Participants will learn and discuss the categories of substances including popular street drugs, rave drugs, date rape drugs and so-called designer drugs.
4. Participants will learn basic testing methods for addictions including the CAGE and SMAST.
5. Participants will learn treatment models (i.e.: Moral, Disease, Behavioral) treatment strategies, including Stages of Change, the Alcoholics Anonymous 12-Step Program and other options, some critical of AA, including the controversial Drinking in Moderation Program.
